**TOWN AND COUNTRY PLANNING BOARD**

**Modification of the Municipal City Council,  
Municipal Town Council and the District  
Council Outline Planning Schemes**

NOTICE IS HEREBY GIVEN that, by virtue of section 24(1) of the Town and Country Planning Act, the Town and Country Planning Board may apply to the President for the revocation and modification of a scheme which has been approved under section 14 of the Act. Section 24(3) of the Act lists that one of the grounds to apply for modification of a scheme is on account of practical difficulties in the execution or enforcement of the scheme. Section 24(4) of the Act states that on application made by the Town and Country Planning Board, the President may modify the scheme.

2. NOW, THEREFORE, NOTICE IS HEREBY GIVEN THAT the President has, on an application made by the Town and Country Planning Board, on account of practical difficulties encountered by the Municipal City Council, the Municipal Town Councils and the District Councils in the execution and enforcement of the Outline Planning Schemes as specified in section 24(3)(b) of the Act, approved that the hereunder Schemes be modified by deleting the words "year 2024" and replacing them by the words "year 2027" so that the hereunder Outline Planning Schemes shall remain in force until December 2027. –

- (a) the Outline Planning Scheme for the Municipal City Council Area of Port Louis;
- (b) the Outline Planning Scheme for the Municipal Town Council Area of Beau Bassin-Rose Hill;
- (c) the Outline Planning Scheme for the Municipal Town Council Area of Quatre Bornes;
- (d) the Outline Planning Scheme for the Municipal Town Council Area of Vacoas-Phoenix;
- (e) the Outline Planning Scheme for the Municipal Town Council Area of Curepipe;

- (f) the Outline Planning Scheme for the Pamplemousses-Rivière du Rempart District Council Area;
- (g) the Outline Planning Scheme for the Moka-Flacq District Council Area;
- (h) the Outline Planning Scheme for the Grand Port-Savanne District Council Area; and
- (i) the Outline Planning Scheme for the Black River District Council Area.
