Apple a dévoilé, mardi, ses nouveaux iPad. La version Pro s'enrichit de la puce M2 et du Wi-Fi 6E. Mais c'est l'entrée de gamme qui fait sa révolution en abandonnant son vieux design et en prenant des couleurs.

Il était le dernier des Mohicans, le village gaulois qui résistait encore à l'USB-C. Cet au design à bords droits. L'iPad d'Apple a fini par céder. Ce 18 octobre, la marque a dévoilé ses nouvelles tablettes tactiles. Si l'iPad Pro ne modifie rien en profondeur, il s'enrichit de la puissance puce M2 des derniers MacBook Air et MacBook Pro, de la compatibilité avec la connexion Wi-Fi 6E et de possibilités accrues pour l'Apple Pencil au niveau de l'écriture. Disponible en 11 et 12,9 pouces, l'iPad Pro supporte également l'enregistrement vidéo en ProRes. Mais la véritable petite révolution qui

a eu lieu concerne l'iPad d'entrée de gamme.

## L'iPad, le début de la révolution (en couleurs)

Le modèle à bas prix d'Apple revoit intégralement sa copie. Fini le design vieillot rappelant les premiers modèles, le capteur d'empreintes sur le bouton et les grosses bordures. Fini, surtout, la prise Lightning pour se recharger : toute la gamme d'iPad s'uniformise et sera désormais en USB-C. L'iPhone reste l'un des derniers à résister.

L'iPad 10e génération prend les mêmes lignes que ses acolytes avec des bords droits et le lecteur d'empreinte sur le bouton latéral de déverrouillage, comme sur l'iPad Air et l'iPad mini. 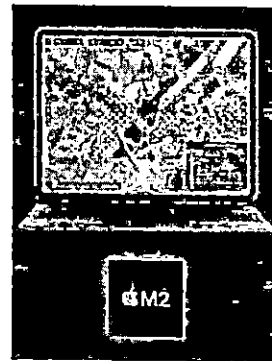

board Folio que l'iPad Air. Cependant, un paradoxe demeure : il est compatible avec l'Apple Pencil 1re génération qui reste, lui, en recharge avec la prise Lightning. Un adaptateur vers USB-C sera, néanmoins, fourni.

L'Apple TV 4K connaît aussi une mise à jour avec l'ajout de la puce A15 Bionic et de la prise en charge du HDR10+, en plus du Dolby Vision.
